#### **BACKGROUND:**

During the Police Department's recent Tier II Illinois Law Enforcement Accreditation (ILEAP) assessment, the ILEAP assessor's identified a shortcoming in that the Code of Ethics for Police Officers that was both in the Rules and Regulations and in the Department's policies had not been updated to the current Law Enforcement Code of Ethics recognized by the International Chiefs of Police Association and which is the standard for both ILEAP and the Commission on Accreditation for Law Enforcement (CALEA). The Department's policy manual was updated to the current Code. The proposed amendment would adopt the Code in the Department's Rules and Regulations.

The current Rules and Regulations contains an organizational chart that is not reflective of the current Department structure. Since an organizational chart is renewed annually in the budget enacting ordinance, it is superfluous to include one in the Department's Rules and Regulations. The proposed amendment would delete the organizational chart from the Rules and Regulations.

#### **KEY ISSUES:**

The major changes to the Code of Ethics are as follows:

- From "As a member of the Bensenville Police Department, my first duty is to serve the people of Bensenville" to "As a Law Enforcement Officer, my fundamental duty is to serve the community;"
- From "I will keep my private life unsullied as an example to all..." to "I will keep my private life unsullied as an example to all and will behave in a manner that does not bring discredit to me or my agency."
- From "I will never act officiously or permit personal feelings, prejudices, animosities, or friendships to
  influence my decisions" to "I will never act officiously or permit personal feelings, prejudices, political
  beliefs, aspirations, animosities, or friendships to influence my decisions."
- Adding the following sentences: "I will never engage in acts of corruption or bribery, nor will I condone
  such acts by other police officers. I will cooperate with all legally authorized agencies and their
  representatives in pursuit of justice. I know that I alone am responsible for my own standard of
  professional performance and will take every reasonable opportunity to enhance and improve my level
  of knowledge and competence."

The current version of the Code and the proposed one are attached to the proposed ordinance.

The Organizational Chart that is proposed to be deleted is attached to the proposed Ordinance. The chart is outdated as it does not list the second Deputy Chief and the two divisions of the Department, Support Services and Operations. It still includes Dispatchers. In addition, it still lists a Code Enforcement Sergeant instead of the Directed Patrol Sergeant.

Whatever I see or hear of a confidential nature or that is confided to me in my official capacity will be kept ever secret unless revelation is necessary in the performance of my duty.


